## Early alert for residents with flood warning system

**PUTRAJAYA:** Residents in flood-prone areas will be warned of rising water levels seven days ahead, once a flood prediction and warning system is in place in October.

This was to ensure that both the authorities and the public would be better prepared to face floods and also to help reduce damage and destruction to property by 30%, said

Deputy Prime Minister Datuk Seri Dr Ahmad Zahid Hamidi.

"We will implement this system in October when all the relevant authorities and agencies start preparing for the monsoon season."

**"The Meteorological Department** has been tasked to come up with the data.

"If there is a forecast of impending floods, the affected people will be informed and evacuated ahead of time," he said after chairing a high-level committee meeting on

disaster management.

With this system, Dr Ahmad Zahid said the Government would be able to overcome delays and lower the risk to lives and property being lost due to floods.

It would also help in logistic planning and distribution of aid, he added.

He said that this system would be useful particularly in dealing with rising water levels in Kelantan, Terengganu and Pahang where floods were almost a

yearly occurrence.

So far, he said the weather forecast showed a mild La Nina was expected to hit the country from now till October.

"The Meteorological Department is anticipating rain but it will not be as heavy as seen in 2014."

"Nevertheless, I have instructed the police, military, civil defence and other bodies to be prepared," he said.

The meeting also viewed several proposed mitigation plans submit-

ted by the three states and the Natural Resources and Environment Ministry where projects estimated to cost RM36bil were presented to the committee.

Dr Ahmad Zahid said the Government was aware of the need to carry out the projects such as deepening of rivers, building higher river banks and opening more water catchment ponds.

"We have yet to approve any of the proposed plans but we will look into it," he said.

## **Rujuk garis panduan telefon pintar CSM elak masalah**

**Kuala Lumpur:** Orang ramai diminta merujuk garis panduan tatacara keselamatan penggunaan telefon pintar dikeluarkan CyberSecurity Malaysia (CSM) bagi mengelak permainan dalam talian termasuk Pokemon Go, menimbulkan sebarang masalah.

Permainan itu memerlukan pengguna telefon pintar mengaktifkan sistem pengeksaan global (GPS) dan kamera, secara tidak langsung dikhuatiri boleh mengancam keselamatan negara.

Ketua Pegawai Eksekutif CSM, Dr Amirudin Abdul Wahab, berkata isu pengharman, sekatan dan ancaman keselamatan aplikasi internet termasuk Pokemon Go adalah di luar bidang kuasa CSM.

Menegaskan pengguna internet perlu melengkapkan diri mengenai etika penggunaan dan aplikasi internet secara positif, katanya, isu berkenaan berada di bawah bidang kuasa agensi penguatkuasaan.

### **Tingkat kesedaran**

"Dari perspektif keselamatan siber, CSM menyediakan bantuan dan khidmat teknikal serta inisiatif usaha meningkatkan kesedaran orang ramai mengenai penggunaan aplikasi permainan dalam talian.

"Ia (tatacara keselamatan penggunaan telefon pintar) bagi memastikan keselamatan diri serta keselamatan maklumat yang disimpan di dalam peranti digital mereka," katanya dalam satu kenyataan yang dikeluarkan di sini, semalam.
