Thanks to new investigation methods and innovative techniques, investigators and forensic scientists nowadays are better equipped to tackle ever increasing challenges in the fight against crime and criminals.

4. However we must always be mindful that **advanced sophisticated scientific instruments alone cannot guarantee the quality of a forensic report. It is crucial that scientific analysis is carried out professionally by the forensic scientists and appropriately used by the relevant authorities.**

Besides technology, forensic practitioners must be equipped with the right knowledge and confidence to assure that the results reported are sufficient and adequate enough without having to spend unnecessary time and money on analyses that may possibly be redundant. As well, forensic scientists must be able to determine whether these advances in technology are really necessary to solve a particular crime or just a luxury when the extra information gathered is not utilised accordingly. **Hence, the theme of this year's symposium "*Necessity versus Luxury*" is indeed appropriate and timely.**

6. I believe that the staging of this event today can contribute towards the **sharing of knowledge and experiences among forensic scientists within the Asian region and help them stay in touch with progress in the scientific world and with each other.**

I understand that this symposium which is being held in conjunction with the annual meeting of AFSN Board members, **offers a wide range of presentation topics that are relevant to the current forensic science scenario, from trace evidence to crime scene investigations.** Every aspect of forensic science analysis and examination is taken care of through the various working groups that have been the backbone of AFSN.

10. **Another example of a successful cooperation is the involvement of the Malaysian forensic team with the International Disaster Victim Identification Team based in the Netherlands that has helped to expedite the DNA identification of victims of MH 17 tragedy.**
